Master of Arts in Regional Studies

Master of Arts in World Regional Studies program at MGIMO University is designed to meet the professional needs to attest newest international trends: rising role of world regions in international relations, world politics and economics important to understand and work in the public service professions, including domestic and international government agencies and non-profit organizations.

The MA in World Regional Studies program provides rigorous on-campus training in quantitative reasoning and qualitative analysis, preparing degree candidates for successful careers in government, higher education, private and non-profit organizations, the media, civil service, international NGOs, research institutions and supplying intellectual breadth, organizational skills, and self-confidence necessary to assume leadership positions in an increasingly complex government and civil service environment. Approximately 80 students are usually enrolled in the program.

Degree Requirements

The year of study begins with an intensive program in World Regional Studies, Politics, International Relations, Economics, designed to strengthen students' skills. All courses are taught in Russian, two foreign languages including English are thought to meet foreign languages requirement by the Ministry of Education and the Ministry of Foreign Affairs of the Russian Federation.

Some courses are essentially lecture/discussion; others are seminars in which students present papers for group discussion; and others are workshops based on simulation games, group reports, case study, field research and participation by visiting experts.

Candidates for admission typically undertake programs of study that combine general courses in quantitative methods, policy analysis and public management with more specialized courses chosen from the School's three fields of concentration. A typical curriculum might include two courses each in economics and public management, a policy workshop, and three courses in one of the free fields of concentration.

World Regions and Comprehensive Regional Studies: Evolution of the Discipline, International Debates, Methodology and Methods

Mandatory course, 4 ECTS credits. The autumn term

Learning results:

- Deep understanding of the evolution and current methodological trends in World Regional Studies — an interdisciplinary field descending from the IR theory, Comparative Politics, and Area Studies.

- Ability to compare methodological standpoints of different international schools of thought, evaluate strengths and weaknesses of competing theories and approaches in World Regional Studies, IR and Comparative Politics.

- Critical thinking skills, basic understanding of the logic and the need for interdisciplinary methodological synthesis.

Assessment: 2 essays, presentation of a methodological review, closed-book exam.

Cross Regional Political Analysis

Mandatory course, 4 ECTS credits. The spring term

Learning results:

- Deep understanding of current disputes in the field of World Regional Studies, ability to demonstrate how they affect theoretical knowledge and analytical findings.

- Ability to apply disciplinary theories to interdisciplinary research, position the topic of one's Master thesis within a broader framework of international scholarship.

- Critical thinking skills, ability to design a research programme, as well as to review and assess methodological correctness of research programmes designed by one's classmates.

Assessment: 2 presentations, essay, peer review of a research proposal, closed-book exam.

The English Language

Mandatory course, 18 ECTS credits. Continuously runs for 3 terms.

Tutors: appointed by the English Language Department.

Learning results: according to the student's personal level of language.

Assessment: essays, grammar exams, oral and written translations, research proposal.

Political Analysis

Mandatory course (Track One), 4 ECTS credits. The autumn term.

Lecturer: Prof. Dr.Pol.Sc. Alexei D. Bogaturov, Distinguished Professor

Seminars: Igor A. Istomin, Andrey A. Sushentsov

Learning results:

- Deep understanding of basic theoretical approaches and methods for political expertise and prognostication (with a special accent on the system approach and computer modeling), ability to employ them in the analysis of international situations and processes.

- Mastering of semi-formal analytical methods (such as logical graphs) and their application in case-studies of current political issues and trends.

- Skills of brainstorming, verification of information derived from open sources, and

interpretation of analytical findings received by collective political expertise.

Assessment: 3 scenarios for situational analysis, foreign policy recommendations, closed-book exam.

Theories of the IR and Regional Integration

Mandatory course (Track One), 4 ECTS credits. The spring term.

Lecturer: Prof. Dr. Marina V. Strezhneva, PhD (University of Manchester)

Learning results:

— Deep understanding of key theoretical issues in the field of contemporary International Relations and Regional Integration (such as transnationalisation, regionalism, and multi-level governance).

— Ability to classify theoretical approaches employed by the IR and Regional Integration Studies according to epistemological principles, explain the historical logic of their development, as well as their comparative strengths and weaknesses.

— Ability to compare and contrast regional integration patterns (e.g. the EU, NAFTA, ASEAN, etc.) against each other, define and explain their characteristic features.

Assessment: essay, closed-book exam.

Financial and Energy Infrastructure of World Economy

Mandatory course (Track One), 4 ECTS credits. The spring term.

Lecturers: Prof. Dr. Olga V. Butorina, Dr. Nikolay Y. Kaveshnikov

Learning results:

— Ability to analyse the most dynamic and important sectors of the contemporary world economy — energy and finance, deep understanding of their architecture, key instruments, and driving forces.

— Ability to explain current trends and problems in the development of global financial and energy infrastructure (including those originated from the 2008 world economic crisis), as well as to analyze the effectiveness of existing political tools for regulation of regional and national markets.

— Deep understanding of Russia's financial and energy security policies, their

correlation with Russia's foreign policy and socio-economic development.

Assessment: case-studies, closed-book exam.

National, Regional, and Global Security Issues

Mandatory course (Track One), 4 ECTS credits. The autumn term.

Lecturers: Prof. Dr. Sergey I. Lounev, Dr. Ekaterina V. Koldunova

Learning results:

— Deep understanding of the global international security system and its regional subsystems, their architecture, as well as social, economic, political, and cultural transformation patterns.

— Ability to implement complex multi-factor analysis for evaluation of retrospective and current security trends on the global, regional, and national levels.

— Mastery of wide-range analytical techniques (including brainstorming, situational analysis, collective political expertise, and mind-mapping).

Assessment: mind-mapping exercise, situational analysis report, closed-book exam.

Federalism and Regional Politics

Mandatory course (Track Two), 4 ECTS credits. The autumn term.

Lecturer: Prof. Dr. Irina M. Busygina

Seminars: Dr. Ekaterina V. Koldunova

Learning results:

— Ability to analyse the pattern of power distribution across territorial structures of modern nations, with regard to key theoretical and practical issues of federalism and regional politics.

— Deep understanding of Russia's complex territorial structure, principles of power sharing and legal interaction between the federal government, regional governments, and local authorities.

— Ability to analyse typical social, economic, and political problems of regions-within-the-state, both in Russia and other countries.

Basic skills of employing GIS for territorial analysis of political processes (elections, etc.).

Assessment: round table presentation, closed-book exam.

Decision Making and Politics

Mandatory course (Track Two), 4 ECTS credits. The spring term.

Lecturer: Prof. Andrey A. Degtyarev

Learning results:

— Deep understanding (and practical application) of contemporary notions, concepts and approaches developed within the political decision-making theory.

— Ability to explore the network structure of a decision-making process at governmental bodies (both legislative and executive); thoroughly analyze its key actors, formal and informal factors, general stages, and dynamics.

— Team-working skills, mastery of policy planning techniques, ability to visualize the decision-making process via cartograms, graphs, etc.

Assessment: 2 essays, collective expertise, oral exam.

Theory and Practice of Business-Government Relations (GR)

Mandatory course (Track Two), 4 ECTS credits. The autumn term.

Lecturer: Prof. Andrey A. Degtyarev

Learning results:

— Deep understanding of basic principles and mechanisms of lobbying and GR, as well as typical forms and methods for interaction with governmental bodies in Russia and abroad.

— Practical skills of elaborating administrative and legislative decision-making projects, drafts of agreements and memoranda, programme for GR campaigns.

— Ability for strategic planning and risk analysis, time, information, and resource management skills, team-working skills.

Assessment: 2 group projects, presentation of individual policy recommendations, oral exam.

THE EUROPE AND AMERICAS MAJOR SCHEME

A Regional Language (*besides English; in conformity with major scheme*)

Mandatory course, 12 ECTS credits. Continuously runs for 3 terms.

Tutors: appointed by the respective Language Department.

Learning results: according to the student's personal level of language.

Assessment: essays, grammar exams, oral and written translations.

Ethnic Psychology and Business Patterns of Europeans and Americans

Mandatory course (Europe and America), 4 ECTS credits. The autumn term.

Lecturers: Prof. Nicolay A. Kosolapov, Prof. Alexander A. Chanyshv, Dr. Ivan N. Timofeev

Learning results:

— Integrated knowledge of ethnopsychological features, national character, ethnic stereotypes, etc. intrinsic to various European\American peoples.

— Deep understanding of ethnic, cultural, and religious traditions, norms and customs, casual and business etiquette, ability to live and work in multicultural environment.

— Ability to critically reassess one's own social and cultural experience, adapt oneself to changes in social and cultural milieu.

Assessment: case-studies, role-playing, simulation games, oral exam.

European and American Foreign Policy of Russia

Mandatory course (Europe and America), 4 ECTS credits. The autumn term.

Lecturers: Prof. Dr. Tatiana A. Shakleina, Prof. Dr. Boris F. Martynov, Dr. Tatiana V. Yurieva

Learning results:

— Deep understanding of the logic, nature and evolution of Russia's foreign policy towards major European, North American and Latin American states, its current priorities, trends, and achievements.

— Ability to analyze potential resources as well as limitations for Russia's participation in multilateral cooperation and regional integration projects in Europe and the Western hemisphere, employing respective methodology.

— Ability to evaluate Russia's diplomatic relations with the US, the European Union

and Latin American countries in both regional and global contexts.

Assessment: essay, presentations, closed-book exam.

Modernization in Europe and Latin America

Mandatory course (Europe and America), 4 ECTS credits. The autumn term.

Lecturers: Prof. Dr. Sergey M. Khenkin, Prof. Dr. Lyudmila S. Okuneva

Learning results:

— Deep understanding of social, economic, and political factors, which lead to establishment of authoritarian / totalitarian regimes, as well as those, which facilitate democratization.

— Ability to contrast intrinsic features of an authoritarian / totalitarian regime against the set of democratic norms and principles, to differentiate national models and patterns of democratic transit, to detect and reveal authoritarian / totalitarian heritage in a transitional society.

— Awareness of the nature, logic, models, legal foundations, dominant trends, as well as social and psychological consequences of international migration, ability to evaluate internal challenges posed by migration to nation-states and “immigrant nations”.

Assessment: essay, closed-book exam.

Security Issues in Europe and the Americas

Elective course (Europe and America), 4 ECTS credits. The spring term.

Lecturers: Prof. Dr. Boris F. Martynov, Dr. Tatiana V. Yurieva, Dr. Sergey S. Veselovskiy

Learning results:

— Ability to critically evaluate contemporary theoretical explanations to the historical evolution of regional security complexes in Europe, North America and Latin America, as well as prospects for future regional security cooperation.

— Understanding of the US role (and Russia’s potential role) in maintaining regional security in Europe and the Western hemisphere.

— Ability to analyze institutional and functional frameworks for regional control

on arms proliferation, conflict resolution, and non-traditional security threats.

Assessment: test, closed-book exam.

European Integration

Elective course (Europe and America), 4 ECTS credits. The spring term.

Lecturer: Prof. Dr. Olga V. Butorina

Seminars: Dr. Anna N. Tsibulina

Learning results:

— Deep understanding of the logic, evolution, driving forces, and internal contradictions of the European integration processes, as well as key dimensions and institutional forms of the EU-Russia interaction.

— Ability to analyze institutional and functional systems of the EU’s relationship with other regions of the world, detect essential problems and dominant trends of their development.

— Ability to critically read and evaluate the scope of the EU documentary base, social and economic statistics.

Assessment: essay, presentations, closed-book exam.

Comparative Political Systems of the Americas

Elective course (Europe and America), 4 ECTS credits. The spring term.

Lecturers: Prof. Dr. Vladimir V. Sogrin, Prof. Dr. Lyudmila S. Okuneva

Learning results:

— Comprehensive analysis of national political systems and political processes in the Western hemisphere (the US and Latin American countries), by employing methodologies of historical knowledge and political science.

— Deep understanding of general democracy types (parliamentary, liberal, etc.) and evolutionary stages of the US democracy model, compared to those of Latin American states. Ability to demonstrate distinctive characteristics and peculiarities of Latin American transits to democracy with regard to national political cultures and historical experiences.

Assessment: 2 essays, closed-book exam.

Political Decision Making in the US and the EU: A Comparative Analysis

Elective course (Europe and America), 4 ECTS credits. The autumn term.

Learning results:

— Deep understanding of political processes in the US and the EU: their key actors, legal mechanisms, and the dynamics.

— Ability to analyze decision-making processes of the US and the EU in the spheres of domestic and (common) foreign policies.

— Mastering of analytical and prognostic methods, including logical (verbal) modeling of various political situations.

Assessment: 2 essays, presentations, oral exam.

Euro-Atlantic Dimension of Global Problems

Elective course (Europe and America), 4 ECTS credits. The autumn term.

Learning results:

— Deep understanding of global problems of the Modernity: their origins, nature, and impact on social, economic, political processes in the integrated Europe and the United States.

— Knowledge and understanding of Russia's Foreign Policy Concept (2008), ability to explain the logic of its regional priorities and legal mechanisms of its development.

— Ability to analyze historical and contemporary trends in Russia's bilateral relations with Asian and African nations, present a grounded vision of Russia's diplomatic reaction to key regional issues with regard to national interests of her Asian and African counterparts.

Assessment: imitative role-playing, 3 press-releases, a mind-map, closed-book exam.

Mandatory course (Asia and Africa), 4 ECTS credits. The autumn term.

Learning results:

— Critical engagement with the scholarly literature on War and Peace Studies, ability

ty to explain and evaluate contemporary theories and approaches to conflict resolution.

— Deep understanding of (and critical reflection on) the origin, types, social forces, mobilisation patterns, and international consequences of major ethnic and religious conflicts in Asia and Africa.

— Ability to unveil and analyze the historical, cultural, social, economic, political potential for de-escalation and peaceful settlement of ongoing conflicts, to develop and present respective foreign policy recommendations.

Assessment: role-playing, foreign policy recommendations, closed-book exam.

Modernization in Asia and Africa

Mandatory course (Asia and Africa), 4 ECTS credits. The autumn term.

Learning results:

— Critical evaluation of competing modernization theories, including theories of dependency, uneven development, underdevelopment, maldevelopment, etc.

— Deep understanding of Asian and African modernization patterns on regional, sub-regional, and national levels, compared and contrasted to those of the Western countries.

— Ability to conduct comparative cross-country analysis of national correlations between Western and indigenous, imposed and adopted, modern (industrial, postindustrial) and traditional, amalgamated in the course of Asian and African modernization efforts.

Assessment: SWOT-analysis reports, presentations, closed-book exam.

Regional (Asian and African) Challenges to the World Order

Elective course (Asia and Africa), 4 ECTS credits. The spring term.

Lecturers: appointed by the Department of Asian and African Studies

Seminars: Anna A. Kireeva, MA

Learning results:

— Ability to critically analyze regional projections of global political, economic,

social, cultural transformations and major challenges to the existing world order posed by Asian and African nations.

— Understanding of the nature of contemporary Asian and African challenges both as potential (or actual) regional problems and threats, *and* as alternative routes for national and regional development.

— Brainstorming skills, ability to reveal and evaluate both positive and negative consequences of Asian and African regional challenges for the global international system of states.

Assessment: essay, 2 PowerPoint presentations, closed-book exam.

Comparative Political Systems and Processes of Asian and African Countries

Elective course (Asia and Africa), 4 ECTS credits. The spring term.

— Case-studies of Asian and African political issues: democratic transits, state corporatism, leadership and legitimacy, elite recruitment, network societies, casteism and communalism, army and civil society, political parties and electoral systems, clerical models of statehood, the Islamic state, non-liberal democracy, and failed states.

Assessment: team-working and group reports, closed-book exam.

Economic Analysis of International and Regional Development: Models and Trends

Elective course (Asia and Africa), 4 ECTS credits. The spring term.

Lecturer: Prof. Dr. Vitaly A. Melyantsev

Learning results:

— Critical evaluation of contemporary theoretical approaches and practical decisions in international political economy, comparative analysis of macroeconomic, po-

litical, and behavioral characteristics of international socio-economic systems.

— Comprehensive knowledge and understanding of economic evolution of both developed and developing states in the global and regional context, explanation of their models and trends.

— Skills of cross-temporal and cross-cultural multifactor analysis of Asian and African macroeconomic strategies, outlining best-case and worst-case scenarios for economic development, assessing their feasibility.

Assessment: PowerPoint presentations, closed-book exam.

Globalization and Regional Integration in Asia and Africa

Elective course (Asia and Africa), 4 ECTS credits. The autumn term.

Assessment: presentations, discussions, closed-book exam.

The Master's Degree in Political Science

The Master's in Political Science (M.P.S.) program at MGIMO University's is designed to meet the needs of rising leaders in the public service professions, including domestic and international government agencies and non-profit organizations by providing up-to-date, firsthand information about Russia and Eurasia from a Russian view point.

The M.P.S. program provides rigorous on-campus training in quantitative reasoning and policy analysis, preparing degree candidates to successful careers and supplying intellectual breadth, organizational skills, and self-confidence necessary to assume leadership positions in an increasingly complex public service environment. Approximately 20 students will be enrolled in the program.

The MGIMO Difference

M.P.S. students benefit from:

- a small Master Degree program designed within a major Russian international studies oriented university;
- a diverse student body and alumni network;
- close working relationships between world-renowned faculty staff;

Degree Requirements

The M.P.S. year begins with an intensive program in politics, international relations, economics, designed to strengthen students' skills. All courses are taught in English. If candidates' command of Russian is adequate, during the M.P.S. academic year they can select additional courses from the courses available to the Russian students of Master Programs in International Relations and Political Science taught in Russian.

Some courses are essentially lecture/discussion; others are seminars in which stu-

dents present papers for group discussion; and still others are workshops based on field research, participation by visiting experts, and group reports.

**МАГИСТЕРСКАЯ ПРОГРАММА
«ПОЛИТИЧЕСКАЯ ЭКСПЕРТИЗА
И GR-СТРАТЕГИИ»**

В каждой профессии есть своя «вершина», для политолога — это, безусловно, квалификация политического эксперта. Экспертно-аналитическая деятельность в сфере политики требует высочайшей квалификации, ума, таланта, способности к неординарным и творческим решениям. Такие люди были во все исторические эпохи — правители всех времен и народов нуждались в них — советниках, помощниках, экспертах. Сегодня в развитом обществе экспертиза — целая система деятельности, объединяющая профессионалов, обладающих специальными знаниями и навыками. Эта система деятельности нацелена на оценку политической реальности, целесообразности осуществляемых политико-экономических программ, прогнозирование развития событий и просчитывание их последствий. Специфика магистерской программы «Политическая экспертиза» заключается в том, что на ее базе готовятся

эксперты, которые, хорошо зная свою страну, ее проблемы и методы управления, одновременно, пользуясь знанием иностранных языков, могут выступать экспертами международных организаций по общим проблемам и «вызовам», с которыми наша страна сталкивается на международной сцене.

Предлагаемая магистерская программа нацелена на формирование у слушателей компетенций, необходимых специалисту-политологу и международнику для работы в сфере политической экспертизы. МГИМО-Университет традиционно ориентирован на создание российской экспертно-аналитической школы, которая позволила бы формировать здраво и самостоятельно мыслящих граждан, способных решать сложные российские и мировые проблемы, одновременно способствуя возрастанию интеллектуального потенциала российского общества. Основной целью программы является практико-ориентированная подготовка экспертов в области публичной политики и политического менеджмента, способных работать как в государственном секторе, так и в бизнес-структурах, НПО.

Магистерская программа:

— во-первых, обеспечивает формирование знаний и навыков в сфере политического анализа, экспертно-аналитической работы и оценке проблемных ситуаций;

— во-вторых, формирует знания и навыки в сфере политического проектирования и подготовки государственных решений в административной и законодательной областях, а также в сфере взаимоотношений бизнеса и государства, государства и НПО по разработке соглашений и управленческих программ;

— в-третьих, обеспечивает знания и навыки в сфере политменеджмента и политуправления на стратегическом и оперативном уровнях.

Магистратура «политическая экспертиза» имеет две специализации:

1. Политические рынки и политические риски.

2. Информационно-аналитическое обеспечение деятельности властных структур.

Специализированный профиль «Политические рынки и политические риски» обусловлен необходимостью преподавания продвинутых курсов в области политической науки по профилю сравнительной политологии в форматах организации политической сферы и управления ею как в Российской Федерации, так и за рубежом. Традиционные интерпретации политики как сферы преимущественных взаимодействий государства и гражданского общества не исчерпывают существенно усложнившуюся структуру и организацию данной сферы. Существует необходимость освоения современного массива знаний генезиса политических рынков и технологий управления ими в целях снижения транзакционных издержек в отношениях между субъектами рынка и минимизации политических рисков ключевых акторов в осуществлении их стратегий.

Специализация «Информационно-аналитическое обеспечение деятельности

властных структур» нацелена на практико-ориентированную подготовку экспертов в области публично-государственной политики и политического менеджмента, т.е. связи с государством в социально-политическом процессе. Выпускники программы должны обладать комплексом компетенций, знаний и навыков, позволяющих проводить самостоятельный прикладной анализ и экспертизу, проектировать решения и осуществлять управленческие воздействия в области взаимодействия с органами государственной власти.

Гибкий учебный план магистерской программы предполагает сбалансированное изучение общенаучных дисциплин и дисциплин специализации. Кроме того, слушатели имеют возможность в дополнение к освоению дисциплин продвинутого политического профиля получить базовые экономические и юридические знания, что позволяет сформировать уникальные индивидуальные образовательные траектории.

Курсы в рамках специализаций читаются, в основном, силами кафедр факультета политологии МГИМО-Университета (декан: профессор, доктор политических наук, доктор философии А.Д. Воскресенский), ведущими профессорами-международниками МГИМО, а также приглашенными специалистами-практиками и иностранными преподавателями. Занятия по прикладным вопросам взаимодействия власти и бизнеса ведут сотрудники Центра развития государственно-частного партнерства, а также ведущих министерств и ведомств Российской Федерации.

Учебный процесс осуществляется в лучших традициях отечественной высшей школы с использованием современных методик преподавания, новейших научных разработок, передового опыта зарубежных вузов. Особое внимание уделяется практическим знаниям и умениям, которые повышают конкурентоспособность выпускников на рынке труда.

В программе преобладают интерактивные формы обучения: круглые столы, ситуационный анализ, ролевые игры, презентации, мастер-классы, коллективная работа над групповыми проектами.

В рамках программы осуществляется подготовка кадров для Министерства иностранных дел России, федеральных и региональных органов исполнительной власти, крупных российских и зарубежных компаний, работающих на российском рынке, а также для научно-исследовательских институтов системы РАН. Предусмотрена возможность прохождения практики в министерствах и ведомствах России (Минэкономразвития России, ВЭБ, иных профильных структурах и организациях). Также существует практика стажировок наиболее успешных студентов в вузах Великобритании, США, Китая и др.

Основным иностранным языком в магистратуре является английский.

Выпускники программы будут обладать необходимой квалификацией для того, чтобы трудоустроиться в качестве:

- кадровых дипломатов и сотрудников международных организаций;
- чиновников сферы государственной власти;
- политических аналитиков, консультантов, управленцев, специалистов в области GR НПО и бизнес-структур;

- международных обозревателей и редакторов СМИ;

- преподавателей высшей школы и научно-исследовательских работников.

Россия-Китай в БРИКС: взаимодействие ученых

НКИ БРИКС в соответствии с утвержденной Правлением программой проводит ряд двусторонних консультаций с национальными комитетами стран БРИКС. В текущем году будут проведены контакты с Китаем, Индией и ЮАР. В рамках реализации этого проекта 20-28 сентября 2013 года состоялся визит представительной делегации российских ученых во главе с заместителем Председателя Президиума НКИ, директором Института Латинской Америки РАН В.М.Давыдовым. В состав делегации вошли также директор Института Африки РАН, академик А.М. Васильев, представители МГИМО (У) МИД России, Института Дальнего Востока РАН, НКИ БРИКС.

Состоялись интенсивные дискуссии с руководством Китайской академии современных международных отношений, Высшей партийной школы и Государственного Комитета по развитию и реформе, Центра по исследованиям современного мира. Также прошла отдельная встреча с заместителем заведующего Международного отдела ЦК КПК Ай Пинюем.

В международном отделе ЦК КПК прошел двусторонний семинар по проблемам взаимодействия стран БРИКС, в том числе по вопросам экономической и финансовой архитектуры и создания Банка развития БРИКС, проблемам мира и международной безопасности, гуманитарного сотрудничества и институционального строительства в рамках механизма БРИКС. В том числе состоялась дискуссия по проблематике использования глобальных правил и режимов торговли в соотношении с торговыми взаимоотношениями в рамках БРИКС, а также приоритетам и направлениям реформы международных финансовых институтов. Итоги встречи показали, что китайская сторона видит в углублении всестороннего сотрудничества в формате БРИКС один из наиболее эффективных путей закрепления тенденции к многополярности мира. Взаимодействие в рамках этого механизма является стратегическим внешнеполитическим приоритетом КНР.

В ходе серии встреч были подробно обсуждены социально-экономическая и внешнеполитическая стратегия двух стран, модальности ее сопряжения в рамках БРИКС, стратегическое взаимодействие России и Китая в вопросах совершенствования глобального управления в условиях продолжения мирового финансово-экономического кризиса. Так китайская сторона подробно разъяснила линию партии и правительства после 18 съезда КПК на обновление страны и реализацию т.н. «китайской мечты». В частности международный отдел ЦК предоставил возможность членам российской делегации ознакомиться с реализацией социально-экономической стратегии КПК в южных районах страны.

Отдельного внимания заслужили и проблемы горячих точек в современном мире, а также вопросы перераспределения баланса сил в различных регионах мира, в частности в АТР. Дополнительно российская и китайская стороны обсудили подходы национальных экспертных сообществ к выработке долгосрочного видения БРИКС накануне экспертного круглого стола в Кейптауне в ноябре с.г.

Все дискуссии проходили в атмосфере дружбы и сотрудничества, и было условлено продолжить диалог, в частности в рамках организуемой НКИ БРИКС в середине октября 2013 года конференции «Взаимодополняемость национальных экономик и сотрудничество стран БРИКС».
